1.	The Society has signed an agreement with MBIE to jointly prepare and issue earthquake geotechnical engineering guidance.	Gavin Alexander

6.	Robert Finch (UCQC) informed the Committee that the outcomes from the SCIRT legacy programme will be set out on a website by the end of the year.	-
7.	As new Seismic Design Guidance documents are released, the Committee agreed that training should be offered. Both UCQC and MBIE representatives at the meeting showed interest in assisting NZGS with this.	Kevin Anderson
8.	Module 1 revision (Liquefaction) is complete and the final review is possibly to be undertaken by Professor Johnathon Bray (TBC)	Kevin Anderson

10.	Robert Finch (UCQC) informed the Committee that work associated with Module 3 (Retaining Walls) is underway.
